**Phillip Hudok** Is there a case pending? That is the 64 thousand dollar question. The reason that Pastor Butch, Pastor House, Gene Stalnaker and I met with your attorney, Steven Travis on January 22, 2015, centered on federal intrusion which is being addressed by you on this site. Since our petitions to all branches of West Virginia government about violations of our state constitution, went unanswered, we were forced to file a complaint, 15-0491 in the Supreme Court of Appeals on May 22, 2015. On September 5, one and only one of the three plaintiffs, Gene Stalnaker, received a letter from Clerk of Court, Rory L. Perry II, a notice that the Supreme Court had refused the "writ" (however, there were 16 writs)!

I was never notified. Were you? This country is about to erupt and to who's benefit? Maybe it is not too late for you to use the uniqueness of the 1872 West Virginia Constitution and how our state can be the key to a peaceful return to the Rule of Law and Constitutional government as intended by our founders.
